ARCIS NextGen Development Project

- **ARCIS NextGen Project**

- Transition from legacy system to a new cloud-based application
- Migration to a new software platform (from Oracle to Salesforce)
- Lift and shift migration of both data and functions for all ARCIS Submodules (40+)

- **Intended Outcomes**

- Cloud based environment with increased system reliability/stability
- Increased system security
- More dynamic platform which is easier to both update and enhance



ARCIS NextGen Development Project

- **Project Timeline**

- Contract awarded and vendor onboarded (CapGemini)
- Project kickoff – October 2023
- 4 Month Discovery Period (Oct 2023 – Jan 2024)
 - Demos of all ARCIS functions
 - Site visits to Lenexa, Lee Summit, Kansas City, and NPRC

- **Agile Development Approach**

- 3 Week sprint cycles
- First development Sprint (0) began February 5th
- Target development completion – Late 2025
- Initial Deployment will be Minimal Viable Product (MVP)
 - Basic “No Frills” functions at launch
 - Additional features added after initial deployment



- **Prior to Deployment**
 - Early Adopter demos of customer functions/processes during development process
 - Provide familiarity with new system's look, feel, and features
 - Elicit customer feedback during development process

- **Deployment**
 - Phased transition approach for FRCs and Agency Customers
 - Planning for dual system use during migration period

Semi-Annual Report of Oversight

- Report covers oversight from July-December 2023
- Focus areas: M-23-07 deadline, managing social media records, and system controls for email and calendaring systems
- Recommendations:
 - Promoting policies and procedures to ensure social media records are managed appropriately
 - Establishing RIM strategic plans and ensuring alignment with agency IRM plans
 - Reviewing and refining procedures to ensure RM controls are incorporated into agency email systems
- Upcoming oversight will focus on M-23-07 reporting data, database controls, and unauthorized disposition safeguards.
