11- memorandum for record. Subj: Norman Rothman

Dated 30 June 1961 prepared by [ ]

2- "When Rothman first came to CIA's attention in September 1958, he was living in Dallas, Texas and was allegedly engaged in public relations work. According to his wife, Gloria, he made a one-week trip to Los Angeles in September on undisclosed 'business.'"

3- In October 1959, Rothman was managing the Biltmore Terrace Hotel in Miami from which he was reported by the FBI to be supplying an anti-Castro organization with arms which he obtained through U.S. gangsters".....

4. Following Pittsburgh conviction, Rothman went to Chicago, where he surrendered on charges of playing a key role in one of the biggest robberies in modern crim. history, the 13.5 million \$ looting of a Canadian bank ... Robbery was touched off when the Canadian branch of the mafia received a hurry-up order from the Caribbean for arms. The Canadian mafia did not have the money to buy arms, but it knew how to ~~reach~~ get hands on the contents of the Brockville, Ontario bank. It called upon the U.S. mafia for assistance, and it was then that Rothman entered the picture, it was charged. "Subsequently portions of loot turned up in Shanghai, Argentina, Cuba & Australia.

5- "Before Rothman was tracked down in connection with the above crimes, he was reported by the FBI as traveling to Yucatan to seek a base of operations against the Castro gov't. In this enterprise he was associated with Eduardo (Teddy) Whitehouse Insuc formerly of the Cuban Civil Aeronautical Association; ex-Colonel Orlando Piedra Negueruela; former member of BRAC and head of Cuban Bureau of Investigations; and Colonel Roberto Fernandez Miranda, brother-in-law of Batista and former commander of the presidential guards as well as president of the National Sports Commission. While no mention is made of Rolando Masterrer in this connection, Rothman has engaged in many exploits and deals with Masterrer."

6- "In September 1960, Rothman still out on \$50,000 bond, made an approach to Frank Fiorini, soldier of fortune, offering to obtain two migs - one flown by a Czech and another by a Cuban. Fiorini felt that Rothman's ~~purpose~~ <sup>interest</sup> was stimulated by a straight profit motive or by hopes for favorable treatment regarding the Federal case against him."

7- In Oct. 1960 R. again appeared in Dallas, where he approached Robert E. Grinnan, an oil contracts promotion man. Rothman claimed to have connections with Nor-Roth Industries of N.Y.C. and stated that clients of his had an interest in purchasing 1/2 million metric tons of diesel fuel oil and one million metric tons of crude oil to be delivered over a five-year period to Hamberg, Germany. Grinnan, puzzled by the offer, reported to the FBI. He went to N.Y. in November and met Rothman and the other principals of the deal, a Mary Talley and a Dr. Phillip Paneth de Panay. Largely because of Grinnan's suspicions the deal was never consummated."

Rothman to destroy the arms dumps on the plantation of ex-pres. Cardenas  
of Mexico, to set up operational bases in the Yucatan at a cost of \$50 -  
\$1,000, to sabotage targets in Cuba identified by the U.S. gov't,  
and to provide positive intelligence on the activities of Chinese Communist  
groups in the Western Hemisphere."

Rothman stated @ Castro had executed 3 of his close friends:  
Rogelio Gonzalez; Sori Marin; Eugenio Fernandez.

2- Operational capability to destroy arms dumps of Cardenas. He had agent assets in Mexico, said he made contact as recently as 4 to 5 months ago @ Mexican friends.

3- Constructed an airstrip in the Yucatan, built by Indians. One B-26 had landed there.

4- Well-acquainted @ Sanchez Arango. Considers him a good personal friend. Last met @ " 6 weeks ago.

5- had the personnel & capabilities to attack or sabotage any target of our choosing in Cuba. He had a basic plan for assass. of Castro. Plan called for an air attack @ napalm against Castro when he was addressing a rally. Had 100 pilots who had participated in invasion of Cuba & now working for Congolese Air Force. Would not identify pilots.

6- Said he had many agents going in & out of Cuba. Said he was in contact @ 6 agents at this time. Agents were in the tourist travel business or export-import businesses, entered US via 3rd countries.

7- knows of many Chinese communists going into Canada from Cuba.

8- expressed resentment over gun-running charges. " said that CIA used the same people in these gun running activities and the same houses, for which he was being prosecuted by the Federal Government. He said that he had supervised 40 ship operations on behalf of the Fronte against Cuba. He said that CIA would truck the stuff to the point

of ship pick-up, where he (Mr. Rothman) would supervise the loading of the ships. He said that he had purchased the 20' ship "reefer" which was the first boat to support the underground in Cuba. He added that he knew everything the CIA planned in maritime operations, and for the invasion."

9 - close friend of John Abbes Garcia, Chief of Dominican Rep. Security  
comment by Simmus - did not believe Rothman's claims of controlling agents and material assets. Recommended no further discussion @ Rothman re these claims.

- During Batista regime Rothman was supervisor of slot machines in Camaguey province under the national supervisor, Alberto Ardura Moya, who was one of owners of Tropicana Nightclub in Havana.

indicates as of Dec 1960 Rothman living in Dallas, but recent reports place him in Miami.

ED Browder - vol 1

Volume one of the Browder files covers the period from 1954 to 1961. A May 28, 1954 cable ~~to~~ from Mexico City reports that Browder was born in Amarillo, Texas on June 22, 1917. He has a long record of passing bad checks and has been convicted twice in federal courts for violation of the Neutrality Act and the theft of govt property in attempting to send 2 planes to assist in the revolution against the Venezuelan government. Under the name of Edward Sabatino, Browder obtained reservations in the Hotel Monte Cassino in Mexico on May 6. "For info ... this man considered either soldier of fortune or provocateur and info wanted on his activity by Havana.

Other Browder aliases: Edward Browder Sabatino, Eduardo Sabatino, Edward Sabatino Ollruier

In a letter from Browder to Mr. Henry Luce (Time-Life), dated 11-15-54, Browder offers Luce exclusive rights in full coverage of revolution in Costa Rica. Browder offers to send a C-47 to Dallas to pick up two of Luce's representatives. In the P.S. Browder says he would like to have George Silk on this assignment. A Nov 19, 1954 letter states that a wire was sent <sup>from Time</sup> saying "sorry cannot undertake."
