By letter to the Director, dated 7/31/63, captioned "Cuban Intelligence Activities in the U. S.", an interview with one EVELIO ESTRELLA CAPOTE, 64 Calle 4, Urbanizacion Marquez, Arecibo, PR. ESTRELLA advised at that time that he had been a member of an anti-CASTRO unit in Cuba named the Thirtieth of November. He was also identified as a former newspaperman. ESTRELLA was interviewed on this ocassion because a letter he had received from Cuba was the basis of a newspaper article concerning activities in Cuba. This person may be identical with the subject.
