1. OP AMTRUNK X POSTPONED TO LATE JANUARY SINCE AMTRUNK/9 HAS NOT RETURNED FROM REF TRIP. AMTRUNK/9 ALONG WITH AMTRUNK/5 (FORMER GUIDE WHO TERMINATED MID-63) AND 3RD PERSON LEFT WAVE AREA 21 DEC 64 FOR AMTRUNK INFIL AREA THENCE HAVANA TO RESCUE JOSE (VASQUEZ) NERY AND 3 OTHERS WHO IN HIDING AT HOME IDEN A. AMICE/14 RCVD INFO FROM BOTH WIFE A/9 AND IDEN B THAT FUNDS FOR OPERATION PROVIDED BY AMFAUNA/3 OSTENSIBLY FROM KUBARK. AMFAUNA/3 IS ACISI SOURCE NO. 180 UNDER WHOSE NET VASQUEZ WORKED UNTIL A/3 EXFILTRATED BY AMTRUNKS SEP 63.

2. ACCORDING WIFE A/9 TRIP PLANNED FOR ONE WEEK DURATION BUT NO WORD YET RCVD FROM AXO TO EXPLAIN DELAY. A/9 WIFE STATES A/9 PLANNED CONTACT AMTRUNK/15 AND 18 TO ARRANGE TRANSPORTATION TO HAVANA. A/9 INTENDED NOTIFY HIS WIFE BY OPEN CODE COMMERCIAL CABLE UPON SAFE ARRIVAL HAVANA AND ALSO PRIOR EXFIL. ON 30 DEC, WIFE A/9 STATES AMFAUNA/3 TELEPHONED IDEN A IN HAVANA. REPORTEDLY VASQUEZ HIMSELF ANSWERED PHONE AND STATED A/9 HAD NOT YET ARRIVED. AS OF 4 JAN,
