Congressman ROBERT EDGAR (D-Pa.), HSCA member, travelled to Ottawa, Ontario, with three staff members and on 4/14/78 met with Deputy Solicitor General P.A. BISSONNETTE and later met with RCMP officers, including the Officer in Charge of Federal Policing Branch.

The purpose of Congressman EDGAR's trip was, according to sources, to obtain a promise of cooperation from the Canadian Government in the HSCA investigation relating to JAMES EARL RAY while he was in Canada. Congressman EDGAR advised Mr. BISSONNETTE that some investigative activity would be directed toward determining if there had been any connection between RAY and J.B. STONER and others of the National States Rights Party.

Congressman EDGAR was received cordially by Mr. BISSONNETTE but no definite commitments were made by the latter beyond the desire of the Canadian Government to cooperate with the U.S. Government whenever it is possible to do so.

Congressman EDGAR got off to a bad start at RCMP Headquarters with an initial remark that one of the purposes of HSCA investigation was "to inquire into the adequacy of the

(prior) investigation." He was informed that the RCMP considered the prior investigation to be adequate in every degree and Congressman EDGAR made repeated efforts to explain away the remark.

RCMP agreed to assist the HSCA by making available any of its members for interview; attempting to locate persons previously interviewed by RCMP and determine if the person was agreeable to interview by HSCA investigators, in the presence of RCMP; and doing name checks on any new names surfaced in the HSCA investigation. RCMP did not agree to allowing HSCA to review its files, to conduct any new investigation for the HSCA or to allow the committee to conduct any investigation in Canada. Congressman EDGAR was told that any requests for investigation in Canada must be presented to the RCMP through the FBI or through diplomatic channels.



This letter serves to confirm the understanding reached between this Committee and the FBI on April 12, 1978, concerning 1) the roles the FBI informants within the Invader organization relative to the activities of Dr. Martin Luther King, Jr., and 2) the possible cooperative postures of the informants who have provided information concerning the relationship between Klan members and Arthur Hanes, Sr., in the course of the latter's representation of James Earl Ray.

As to the Invader situation, it is understood that the FBI will locate and sanitize the informant files of all informants within the Invaders during 1968 and provide the Committee with access to these files. The sanitizing process will be undertaken only to the extent necessary to protect the identity of the informants. The FBI will also provide the Committee, for interview purposes, with the control agent or agents for these Invader informants. This Committee, however, reserves the right to request production of the identity of all Invader informants during 1968 should the sanitized files and agent interviews be inconclusive on the issues to be resolved by the Committee.



Mr. Keuch further advised that the documents requested by the Committee are heavily excised due to sensitive informant information, and these excisions have raised questions on the part of the Committee which can only be resolved by a briefing for Louis Stokes, Chairman, Samuel L. Devine, Ranking Minority, and G. Robert Blakey, Chief Counsel to the Committee. Mr. Keuch has indicated he will discuss this matter with the Attorney General [and will recommend that these individuals be briefed on the "Solo" operation] He desires to obtain the FBI's views for the briefing concerning these specific individuals. In the course of a file review in an unrelated matter, SL 3167-C, St. Louis File 137-16185, Bureau File 137-36945, was reviewed. This file contained a contact memorandum dated March 19, 1974, which contained information relating to several criminal matters and also contained the following paragraph:

"During the Fall of 1973, five or six months ago, date not recalled, Beyers came to the shop inquiring as to whether they could get together to talk, and they later did so at Pizza and Cream, Clayton, Mo., in the area of a Broad-Dugan Paint Store, where informant had traveled on business. Beyers talked freely about himself and his business, and they later went to informant's house where Beyers told a story about visiting a lawyer in St. Louis County, now deceased, not further identified, who had offered to give him a contract to kill Martin Luther King. He said that also present was a short, stocky man, who walked with a limp. (Later, with regard to the latter individual, Beyers commented that this man was actually the individual who made the payoff of James Earl Ray after the killing.) Beyers said he had declined to accept this contract. He did remark that this lawyer had confederate flags and other items about the house that might indicate that he was 'a real rebel'. Beyers also commented that he had been offered either \$10,000 or \$20,000 to kill King."

Extensive further research in the St. Louis indices and files failed to reveal this information was if any way disseminated and the information simply reposes in the informant file.

On March 16, 1978, from 2:12 p.m., to 3:54 p.m., SA James W. Sammon, assigned Jackson, Mississippi, FBI Division, appeared before representatives of the House Select Committee on Assassinations (HSCA) at Washington, D.C.

SA Sammon was questioned by Mark A. Speiser, Peter G. Beeson, and Wendy S. Collins, all of whom identified themselves through the use of credentials, as being associated with aforementioned committee. (214)

At the outset, SA Sammon was asked to furnish background information concerning his career with the FBI, the number of offices and dates assigned and classifications worked.

SA Sammon was asked to identify Special Agents in Charge (SACs) and Assistant Special Agents in Charge (ASACs) assigned to the Miami, Florida, FBI Office during the period of 1961-1964, when SA Sammon was so assigned to that office. The identity of these SACs was furnished as Wesley G. Grapp and Fred A. Frobrose (phonetic). It was explained that former SAC Frobrose is now deceased.

SA Sammon was asked to identify members of his squad while he was assigned to the Miami Office. SA Sammon advised that he would be unable to identify each and every Agent assigned to the Number 5 squad during the years of 1961 and 1964 inclusive, due to the length of time that had transpired since that period.

This document contains neither recommendations nor conclusions of the FBI. It is the property of the FBI and is loaned to your agency; it and its contents are not to be distributed outside your agency.

SA Sammon was then asked if SAs Francis McCarron, Jack Dawson, Vincent Stacey, Leon Pryor, and Leonard C. Peterson were assigned to the Number 5 squad in Miami from 1961 through 1964. SA Sammon replied that SAs McCarron, Dawson, and Peterson were assigned to that squad; however, it was not Sammon's recollection that either Stacey or Pryor were so assigned.

SA Sammon was then asked to give a breakdown by classifications as to the responsibilities of each of the six Miami squads from 1961 through 1964, which information was furnished to the committee representatives. SA Sammon was asked to elaborate on the assignment of responsibilities to the Number 5 squad of Miami during that period of time. Those classifications furnished of that squad were applicants, accounting matters, including Hoffa and teamster investigations; civil rights; racial matters; and fugitive matters. It was explained that these were the major classifications assigned the Number 5 squad.

SA Sammon was questioned regarding his transfer from Miami to the Jackson Division in July, 1964, his location and investigative responsibilities while assigned to Mississippi, which reply was to the effect that Sammon was assigned to the Clarksdale, Mississippi, Resident Agency from 1964-1969, and to the Jackson, Mississippi, Headquarters of the FBI from 1969 to the present time. SA Sammon advised that while assigned to the Clarksdale, Mississippi, Resident Agency, he worked any and all investigative matters under the jurisdiction of the FBI which pertained to the territory covered by that resident agency. In response to a direct question, SA Sammon advised that his transfer from Miami to Jackson, Mississippi, was a routine nature and not of a disciplinary nature.

In response to a direct question, SA Sammon advised that he was the "backup Agent" assigned to Bill Somerset, an FBI informant, while SA Sammon was assigned to the Miami Division during the period of 1961-1964.

SA Sammon was asked to identify Intelligence Division Officers of the Miami, Florida, Police Department, which SA Sammon was unable to do, nor was Sammon in a position to advise whether or not any information furnished by Somerset was disseminated to that intelligence unit during the period of 1961-1964.

SA Sammon was then queried at length regarding Ku Klux Klan activity in Mississippi beginning in 1964, in particular, information regarding United Klans of America (UKA), White Knights of the Ku Klux Klan (WKKKK); and the "Silver Dollar Group" of the WKKKK Mississippi. SA Sammon furnished a lengthy dissertation regarding Klan activities in Mississippi since his arrival in 1964.

SA Sammon was then asked if he had conducted any investigation regarding "Merkin". SA Sammon replied that immediately after the shooting death of Dr. Martin Luther King, SA Sammon was assigned the responsibility of traveling through North Mississippi with photographs of the evidence left by King's assailant, exhibiting those photographs at motels, service stations, in North Mississippi to determine if any of the photographs could be identified.

SA Sammon was asked if he was aware of Somerset's attempt to assassinate King in Montgomery, Alabama, in 1958 through poisoning his food. SA Sammon advised the committee that he was not aware of any such attempts.

SA Sammon was then queried regarding Bureau regulations regarding amounts of money paid informants and policy of the Bureau to overseeing those payments. SA Sammon explained to the committee that such amounts are normally determined by the Agent contacting the informant and are paid on a COD basis based on the value of the information furnished by the informant. SA Sammon advised that the Bureau oversees these payments only in an auditing or accounting of the particular informant's payment fund.

SA Sammon was then questioned regarding the Bureau policy in discontinuing informants and if the informants are advised that they are being so discontinued. SA Sammon advised that the informant is so advised when he is discontinued, usually determined when the informant has furnished a lack of positive information, or when he has exposed himself as an informant, and of course upon his death.

SA Sammon was then questioned regarding Somerset's personal involvement in violence; Somerset's personal bigotry toward minority races; his bigotry regarding union membership; his carrying of weapons; and Somerset's knowledge of explosive devices; and information furnished by Somerset regarding Thomas Albert "Tommy" Tarrants.

To these questions, SA Sammon advised that he did not have any personal information of acts of violence performed by Somerset; and that the only personal bigotry exhibited by Somerset was Somerset's apparent dislike for SA Sammon, as Somerset felt that SA Sammon was of Jewish descent. SA Sammon advised that he had no knowledge of any acts of bigotry in union membership as indicated by Somerset, nor was SA Sammon aware of Somerset ever carrying a weapon or Somerset's knowledge of any explosive devices. SA Sammon advised the committee that he did not recall Somerset ever furnishing any information regarding Thomas Albert "Tommy" Tarrants; however, SA Sammon was acquainted with Tarrants, having been involved in a firearms shootout confrontation with Tarrants in 1969. The committee pressed for further details concerning this shootout and the committee was advised that in August, 1969, Tarrants and two other inmates of the Mississippi State Penitentiary (MSP), Parchman, Mississippi, escaped from that penitentiary and were thereafter subjects of an unlawful flight to avoid confinement investigation, and were considered by the FBI to be Federal fugitives. The committee was advised that in August, 1969, information was received by the Jackson, Mississippi, Office that the three escapees were hiding in a heavily wooded dense area near Jackson, Mississippi. Thereafter, SA Sammon and many other Jackson, Mississippi, Agents attempted to locate and apprehend Tarrants and the two other inmates, which attempts resulted in a gun battle, causing one of the inmates, name unrecalled, to be killed by

law enforcement officers, consisting of FBI Agents, Mississippi Highway Safety Patrol (MHSP) officers, and those of the Rankin County Sheriff's Office. The committee was advised that this was SA Sammon's first and last contact with Tarrants. SA Sammon in answer to specific questions, advised that he had no personal knowledge of the acts of Tarrants performed on a residence of a Jewish businessman in Meridian, Mississippi.

SA Sammon was then questioned regarding the availability of FBI informants to other Federal or local law enforcement agencies, and the Bureau policy as pertaining to that availability. SA Sammon advised the committee that it is the practice of the FBI, as well as other law enforcement agencies, not to reveal the identity of Bureau informants to those agencies, even though the information furnished by those informants may be disseminated to those agencies.

The committee at this point took exception with SA Sammon indicating it was their feeling that the FBI "receives all information but does not share information" with other law enforcement agencies, Federal, state, and local. The committee at this point was unequivocally advised that this has not and is not the case of the FBI, and that information obtained by the FBI which is of an interest to those agencies, is disseminated to them, even though the identity of the informant furnishing such information is not revealed to those agencies.

SA Sammon was again asked for his knowledge as to the availability of Bill Somerset to the Intelligence Unit of the Miami, Florida, Police Department, to which SA Sammon again advised that he was not aware of such availability during the years of 1961-1964, the only period that SA Sammon was acquainted with Somerset.

SA Sammon was asked as to the degree of confidence and reliability regarding the information furnished by Somerset while an FBI informant. SA Sammon advised from 1961-1964, it was his opinion that the information furnished by Somerset was reliable, and that SA Sammon had confidence in that information.

At one point during the questioning, when SA Sammon was being questioned as to squad assignment classifications, and identities of Agents of the Miami, Florida, FBI Office from 1961-1964, SA Sammon advised the committee that as that period of time was from 14-17 years in the past, SA Sammon would try to be as accurate as possible as to months and years involved; however, the committee was reminded SA Sammon's recollection of the events may be six months to perhaps a year off. Mark Speiser advised SA Sammon that the committee would only allow a four month leeway. This comment may have been misunderstood by SA Sammon and may have been in jest by Speiser; however, in any regard, Speiser was advised that SA Sammon stood on his previous statement that events occurring 14-17 years ago would be timed as accurately as SA Sammon possibly could; however, there would be no "four month allowance" imposed on SA Sammon, unless the committee intended to furnish him documentary verification. There was no such documentary verification furnished SA Sammon during his interrogation, with the exception of SA Sammon being furnished a lengthy article from what appeared to be the "Parade" or pictorial section of the Miami, Florida, Herald, Sunday Supplement Newspaper, which article appeared to be regarding Bill Somerset. This article was furnished SA Sammon briefly in an effort to identify Somerset by photograph as it appeared in the article. SA Sammon was unable to positively identify Somerset, due to the length of time involved, and the fact that the photograph was not a good likeness, or Xerox copy, as the photograph of Somerset, made him appear older and thinner in appearance. SA Sammon advised the committee that the poor photograph did resemble Somerset; however, if the committee had not advised Sammon that it was of Somerset, SA Sammon would be unable to identify him. SA Sammon was not furnished the article to read.

SA Sammon was furnished a name of an individual in Miami, Florida, which name SA Sammon failed to record, and therefore the identity of that individual is not recalled by SA Sammon. SA Sammon was asked by the committee if he was acquainted with this individual. SA Sammon advised the individual was unknown to him.

SA Sammon was then advised that this individual was a house painter in Miami, and SA Sammon was asked if Bill Somerset was acquainted with this individual.

SA Sammon advised that he then recalled that this individual may be identical to a person who was at the scene of the James Meredith integration disorder at the University of Mississippi, Oxford, Mississippi, which SA Sammon believed to be in 1963. The committee was advised that the incident arose over Meredith, a Negro, attempting to register to attend the University of Mississippi.

SA Sammon recalled that a lead was received at the Miami Office to identify and interview this Miami house painter as his vehicle had been observed at the University of Mississippi campus during the disorder involving the registration of Meredith at that university.

SA Sammon advised that he and SA Leonard C. Peterson contacted Bill Somerset for background information on this individual and that Somerset was acquainted with house painter and furnished SA Peterson background information concerning this individual, to the best of SA Sammon's recollection involving the house painter being a member of National States Rights Party (NSRP).

Thereafter, SA Sammon assisted SA Peterson in the interview of this individual in Miami in either the summer of 1963 or 1964. SA Sammon recalled that the individual was painting a house at the time of the

interview, was very hostile towards the interviewing Agents; however, at the persistence of SA Peterson he was interviewed regarding his appearance at the University of Mississippi.

A short time thereafter, an article appeared in the newspaper of the NSRP on the front page which was submitted by this house painter. This article referred to his interview with SA Peterson and SA Sammon, and referred to Peterson as "a blond haired Swede" and to SA Sammon as "a Jew bastard" or words to that effect.

SA Sammon was asked if he was acquainted with Joseph A. Milteer, or if Somerset ever furnished any information regarding Milteer and his activities. SA Sammon advised he was not acquainted with Milteer and did not recall Somerset furnishing any information regarding him.

 Reference is made to letter to the Attorney General from G. Robert Blakey, Chief Counsel and Director, HSCA, dated March 7, 1978, which, in connection with the HSCA's investigation into the assassination of Martin Luther King, Jr., requested certain material from files of the FBI.

On April 7, 1978, HSCA staff member Peter Beeson advised that it is not necessary to process material in response to Item 1 of referenced letter, Birmingham Field Office files on the United Klans of America.

Information concerning Item 2, Miami Field Office file concerning William A. Sommersett, has been processed and is available for HSCA access at FBI Headquarters.

With respect to Item 3, information pertaining to the FBI's informant coverage of listed extremist organizations, Mr. Beeson furnished the following modification on April 7, 1978. It will not be necessary for the FBI to furnish an informant numerical breakdown on the national level for these organizations. The HSCA desires to know whether or not informant coverage was effected at the national and state levels for each organization. Also, the number of informants covering each group is desired for New Orleans, Birmingham, Memphis, Chicago, Atlanta and Los Angeles. The State of Mississippi can be eliminated. Finally, the HSCA desires to know the number of informants in these groups who were officers and the number who were only rank-and-file members. Any report prepared by the FBI's Inspection Division concerning the quality and quantity of informant coverage in these localities for these organizations is also needed. Efforts to respond to this item are underway and the HSCA will be advised upon completion.

Retrievable information concerning individuals listed on pages 2 and 3 of referenced request has been processed and is available for HSCA access at FBI Headquarters.

By letter dated December 13, 1977, this Committee requested that the Department of Justice and the Federal Bureau of Investigation, respectively, provide the Committee with documents and lists of attorneys and agents relative to a) the FBI COINTELPRO program directed against Dr. Martin Luther King, Jr., and b) the MURKIN investigation.

By January 25, 1978, the FBI had complied with that portion of the request which pertained to its files and its agents. However, the Department of Justice has yet to supply the similar materials requested of it. Any further delay in compliance will begin to interfere substantially with the efforts of this Committee to resolve in a professional and thorough manner any issues surrounding the responsibility of Federal law enforcement and activities in the conduct of the MURKIN investigation. Therefore, in order to avoid a delay with such effects, it is necessary that the Department of Justice comply with this Committee's request of December 13, 1977 by no later than April 10, 1978.

Your cooperation in this matter will be greatly appreciated.

THIS SECURITY INVESTIGATION OF KING BY ATLANTA HAD BEEN ASSIGNED TO SA ALAN G. SENTINELLA ON MAY 21, 1965, AND SA SENTINELLA HAD THIS CASE ASSIGNED TO HIM FOR THE ENTIRE PERIOD OF 1967-1968. SA SENTINELLA'S ATLANTA SUPERVISOR DURING 1967 AND 1968 WAS SA CHARLES S. HARDING.

ATLANTA THEN REVIEWED VOLUMES 59 THROUGH 80 OF THE KING SECURITY FILE AND IT WAS NOTED THAT SA ALAN G. SENTINELLA APPEARED TO BE THE ONLY ATLANTA AGENT THAT TOOK AN ACTIVE PART IN THE HANDLING OF THIS CASE IN 1967-1968. 



Special Agent (SA) Richard D. Rackleff, Federal Bureau of Investigation (FBI), Atlanta Division, was contacted telephonically on Friday, March 17, 1978 by Robert Walker who identified himself as a Staff Investigator for the House Select Committee on Assassinations (HSCA). Walker made arrangements to meet with SA Rackleff at the intersection of North Avenue and Spring Street, Atlanta, Georgia, at 11:00 AM on Monday, March 20, 1978. Walker stated he would be in the company of a second Staff Investigator whom he identified as Mr. Reeves, a black male.

At 11:00 AM on March 20, 1978, SA Rackleff met with Robert Walker and Floyd Reeves, both of whom displayed credentials identifying themselves to be members of the Investigative Staff of the U. S. Congress. Reeves conducted the questioning and requested the information relating to the neighborhood canvassing conducted by SA Rackleff in the vicinity of North Highland Street and Ponce de Leon Avenue in April, 1968. Reeves inquired as to the person or persons coordinating the investigation conducted in the Atlanta Division and specifically asked whether other areas

of Atlanta were canvassed in addition to this one particular area. Reeves specifically asked if other areas which were identified by markings on a map recovered from the apartment of James Earl Ray were canvassed in addition to this one area near North Highland Avenue and Ponce de Leon.

SA Rackleff explained he could not recall specifically how many markings were on the map, but believed there were basically four areas marked. He stated three of these markings were identifiable as being significant to the approximate location of the home and church of Doctor Martin Luther King, Jr. and the apartment of James Earl Ray. The fourth marking on the map as recalled by SA Rackleff was not significant or identifiable with any known activity of either James Earl Ray or Dr. King, and therefore an extremely thorough, door-to-door survey was conducted in an area well beyond the boundaries of the fourth marking on the map. Each and every adult member of each household was contacted and interviewed concerning any knowledge or association with James Earl Ray or Dr. Martin Luther King. Photographs of Ray were displayed and as best as could be recalled, there was no pertinent information developed specifically identifying any associates of either James Earl Ray or Dr. King.

The Special Agent in Charge of the Atlanta Division was identified as Frank Hitt, and the Assistant Special Agent in Charge at that time was identified as Jack Keith, Jr.

Mr. Reeves requested an additional interview of SA Rackleff in the Conference Room at the Headquarters of the Atlanta Police Department at 3:00 PM on that same date for the purpose of displaying a replica

of the map recovered from Ray's apartment. At 3:00 PM, a second interview was conducted by Mr. Reeves and Mr. Walker. Mr. Reeves displayed what he identified to be a replica of the map recovered from Ray's apartment in April, 1968 and also displayed a legal sized handwritten paper showing separate investigations conducted by SA Harry Lee, SA James Riordan, and SA Rackleff in 1968. The investigation by SA Rackleff identified the streets and addresses canvassed during the neighborhood investigation. SA Rackleff explained that he reported to the Atlanta Office in about January 1968, and at the time of the investigation of the King assassination, he was not familiar with the streets and locations. SA Rackleff was unable to recall specifically observing the map displayed by Mr. Reeves, however, did identify three of the general areas marked as being the approximate location of the home and church of Dr. King and the apartment of James Earl Ray near 14th Street and Peachtree Street, N.E. The fourth marking on the map was identified as the area in which SA Rackleff conducted the above described neighborhood investigation.

SA Rackleff expressed his full and complete cooperation with the investigation of Mr. Walker and Mr. Reeves and Mr. Reeves stated they were very much appreciative and might request additional interviews at a later date.

On March 24, 1978, I, Leonard C. Peterson, former Special Agent of the Miami Office of the Federal Bureau of Investigation, was interviewed by Peter G. Beeson, Staff Counsel, Richard C. Wrose and Mark Speiser, investigators for the House Select Committee on Assassinations at the Airways Motel, Miami, Florida.

I furnished general information about my Bureau career, offices of assignment and arrival in Miami, Florida, office in April, 1960. Shortly after arriving in Miami, I took over as the principal contact for William Sommersett, a highly placed extremist source, in the Miami Division, and continued in this assignment until the Fall of 1961. I related the following information to the investigators to the best of my recollection.

Sommersett was discontinued in late 1961 for his personal safety and possible embarrassment to the Federal Bureau of Investigation. Sommersett was characterized as a source who had furnished reliable information in the past and, in addition, had furnished information which could not be verified or corroborated. Sommersett's work for the Federal Bureau of Investigation covered a span of twelve to fourteen years, having started out in New Orleans Division where he furnished information on White Slavery and local police corruption. He later worked out of the Charlotte Division furnishing information on criminal matters and Klan activities in the eastern part of the North and South Carolinas. Following his work in the Charlotte Division, Sommersett came to the Miami Division where he furnished some criminal information, possible violations of labor

matters and principally worked during the last two or three years as a source on extremist matters covering the southeastern section of the United States. Sommersett made some fourteen or more trips out of the Miami Division to various states in the southeast including Georgia, Louisiana, Tennessee, Mississippi and North Carolina, reporting on Klan organizations and leaders of White Hate Groups. After Sommersett was discontinued, he continued to furnish information that he felt was of interest to the Federal Bureau of Investigation even though he was never reimbursed for this information.

Contact with the Federal Bureau of Investigation was initiated by Sommersett and as time passed he initiated fewer and fewer contacts. After Sommersett had been discontinued he notified the Federal Bureau of Investigation about a group responsible for the bombing at the home of Donald Shoemaker, Editor of the "Miami Herald". This information was furnished to the Miami Police Department and Sommersett was placed in contact with the Intelligence Unit of the Miami Police Department who continued the bombing investigation, utilizing Sommersett and other sources. This later resulted in the prosecution and conviction of two individuals involved in the bombing.

The Miami Police Department continued to use Sommersett on extremist matters, including trips they sent him on to other states. The extent of the information developed by Sommersett and subsequently furnished to the Miami Division is not clear. Some information was furnished; however, there was a feeling that the Miami Police Department was reluctant to furnish information developed by Sommersett since they were utilizing him outside of their jurisdiction.

The investigators were primarily interested in information developed by Sommersett on or about April 3, 1968, in Washington, D.C., to the effect that Martin Luther King was to be assassinated in Memphis, Tennessee. I do

not recall having received this information from the Miami Police Department or Sommersett. I vaguely recall that something to this effect did come up later, but I am unable to put it in any time frame and why I only vaguely recall such a development. The investigators exhibited to me a memorandum, dated April 25, 1968, from Sergeant Sapp of the Miami Police Department to Chief Headley of the Miami Police Department. This memorandum related a call from Sommersett to Sergeant Sapp on or about April 4, 1968, reporting on Sommersett's trip to Washington, D.C., where he learned of a plot to assassinate Martin Luther King. The memorandum goes on to state that the Miami Police Department sent Sommersett to Atlanta, Georgia, to make contact with White Hate Groups in an effort to develop additional information on the assassination of Martin Luther King. I do not recall having previously seen this memorandum or if a copy was furnished to the Miami Office of the Federal Bureau of Investigation.

Following the interview, I was advised that I would be notified in the event I am needed to testify at an open hearing in Washington, D.C., before the House Select Committee on Assassinations.

On March 17, 1978, Special Agent Jim Haggerty, St. Louis Field Supervisor, was contacted regarding additional information concerning this matter. Haggerty advised that St. Louis informant had spoken with Russell George Beyers who is a fence in the St. Louis area. Beyers was opened as a source (SL 137-16541; Bufile unknown) on October 3, 1975, and closed November, 1976. A copy of the original source contact memorandum was placed in Beyers' informant file and an 87-file, however, there is no evidence that Beyers was ever questioned about the meeting with the deceased St. Louis attorney. Additionally, there is no evidence that this information was ever acted on or disseminated outside the St. Louis Office. Beyers was arrested approximately two weeks ago by the St. Louis Police Department as suspect in a St. Louis museum burglary and this precipitated the file review which surfaced the information in question. Haggerty stated that both the Agent and Supervisor who handled original contact memorandum with St. Louis informant have retired. The original St. Louis informant (SL 3167-C; Bufile 137-36945) to whom Beyers spoke has been closed as an informant and is residing in Chicago, Illinois.

Response regarding Beyers' informant status was coordinated with Special Agent Jeff Jamar, Criminal Informant Unit, Division Six.

A search was made of the central records index for Russell George Beyers. The only reference to Beyers was in Bufile 87-129497-11, which concerned Beyers' possible involvement in fencing the proceeds from a St. Louis museum theft. No Bureau informant file was located.

Original St. Louis letterhead memorandum dated March 13, 1978, contained informant symbol number, and St. Louis and Bureau informant file numbers, and was, therefore, retyped with this information deleted.

As the HSCA is expected to have an intense interest in this information, it is being furnished in memorandum form through the Department to the Committee.

In the course of a file review conducted at the St. Louis FBI Office in an unrelated matter, a St. Louis informant file was reviewed. This file contained a contact memorandum dated March 19, 1974, which set forth information relating to several criminal matters and also contained the following paragraph:

"During the Fall of 1973, five or six months ago, date not recalled, Beyers came to the shop inquiring as to whether they could get together to talk, and they later did so at Pizza and Cream, Clayton, Missouri, in the area of a Broad-Dugan Paint Store, where informant had traveled on business. Beyers talked freely about himself and his business, and they later went to informant's house where Beyers told a story about visiting a lawyer in St. Louis County, now deceased, not further identified, who had offered to give him a contract to kill Martin Luther King. He said that also present was a short, stocky man, who walked with a limp. (Later, with regard to the latter individual, Beyers commented that this man was actually the individual who made the payoff of James Earl Ray after the killing.) Beyers said he had declined to accept this contract. He did remark that this lawyer had confederate flags and other items about the house that might indicate that he was 'a real rebel'. Beyers also commented that he had been offered either \$10,000 or \$20,000 to kill King."

Extensive further research in the St. Louis indices and files failed to reveal this information was in any way disseminated and the information simply reposes in the informant file.

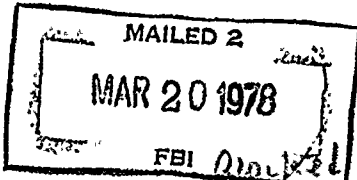

NOTE: The personal file of former Assistant Director William C. Sullivan, maintained in the Special File Room at FBIHQ, contains primarily tickler copies of communications in the security file of King. The security file on King, up to April 1, 1969, has already been delivered to the HSCA. Therefore, most documents included in the attached Sullivan material is already in possession of the Committee. Information of a sensitive nature in the Sullivan file involves copy of a typed letter allegedly written to King and received in the mail along with a tape by the King family in 1964 and a written account of King's alleged encounter with a Las Vegas prostitute.

With regard to Item 2 of referenced letter, on March 13, 1978, Mr. Blakey modified the HSCA request for FBI Manuals, desiring only Sections pertaining to security informants, extremist informants, civil rights, fugitives, murder and conspiracy for the years 1962-1963 and 1967-1968. Efforts to respond to this item are continuing.
